I.C.C. organized a talk 'Sexual Harassment at workplace' on 26th October. Ms. Poonam, lawyer at Session Court and High Court addressed the students. She threw light on legal rights of women in case of sexual exploitation at work, home or at any place. She is also the Editor of 'Equality Magazine' (आधीजमीन). The other eminent speaker Ms. Kavita Krishanan, member of 'All India Progressive Women's Association' (प्रगतिशीलमहिलासंगठन) held a dialogue with regarding their safety and course of action in case of victimization. Both the speakers are women activists and have played a significant role in 'Nirbhaya Movement'. They also told the students that they can be approached anytime in future in case of necessity.

Notices sent by the University about the menace of ragging are on display at all important places in the college.

In order to spread awareness regarding sexual harassment, a talk was organised on 20th September 2017 in the college premises with three honourable guest speakers Ms. Meera Kaura Patel (Advocate of high court), Ms. Pyoli Swatija (Advocate of Supreme Court), Mrs Santosh Khanna (Member of NGO and founder of Vidhi Bhartiya Parishad). 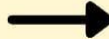

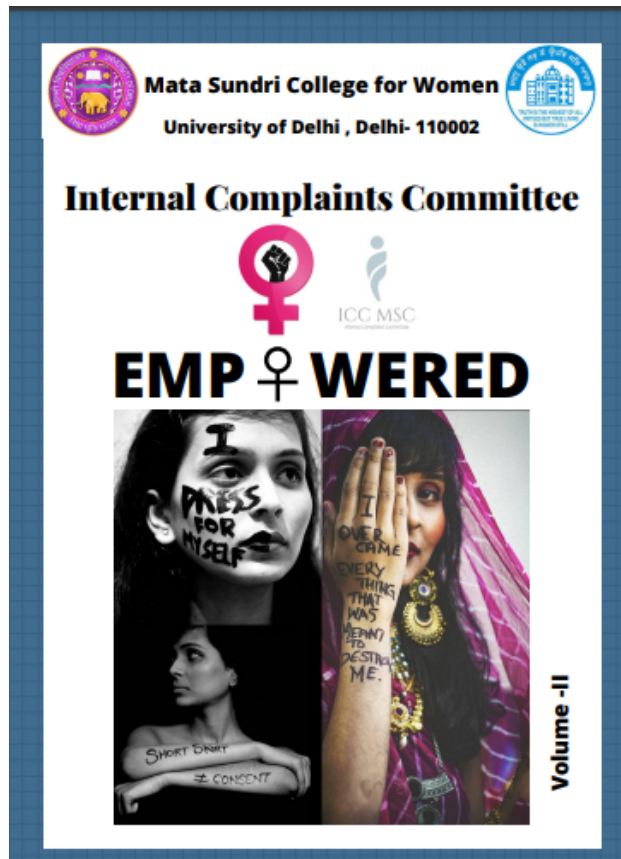
