This appointment is subject to the following terms and conditions:-

1. That this offer of appointment is subject to successful verification of the following original documents in respect of educational qualification, age, category and other necessary documents:-
 - a. Date of Birth.
 - b. Educational Qualification, NOC etc.
 - c. Category, Status, Caste/Tribe Certificate.During the verification or at any later stage/period of service, if any discrepancy is found, this offer of appointment shall stand cancelled without assigning any reason.
