

MEMORANDUM OF UNDERSTANDING

BETWEEN

Mata Sundri College for Women (hereafter “MSC”)

AND

GirlScript Foundation (U74999MH2017NPL295682) of Nagpur, MH-440027 (hereafter “GS”)

This Agreement made and entered into on the 5th day of December 2020 between MSC and GS.

1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

i) To provide a formal basis for initiating interaction between MSC and GS in mutually beneficial areas such as:

Deliverables from GS: -

- Promotion of MSC as **OUTREACH PARTNER** through all social media handles.
- Invitation to one of the dignitaries from the college for a special session.
- ₹ 100 per student registered for the welfare and development of MSC (**IFF** the count of student for **Short Term Course on “Graphics Designing & Web Development” (STC)** is 30 or more than 30). The detailed proposal of the STC is separately enclosed with this document.
- MSC Principal Signature and MSC Logo on the Certificates.
- Assessment Exam to be conducted at the end of **STC**
- Result Report Card of Students for the Assessment Exam
- Issue of Course Completion Certificate to Students and Certificate of Appreciation to MSC Programme Coordinators within 10 days of **STC** Completion
- To stop the spread of Covid pandemic, all sessions will be conducted Online.

Expectations from MSC: -

- Promotion of GIRLSRIPT and **STC** through official social media handles.
- Promotion of **STC** within MSC, all associated colleges, branches, sections, streams and years.

- Target around 30 + participants before 1st January, 2021

- MSC can take the registered amount initially through their link and share 50% amount BEFORE 25th December to GS.

- Remaining 50% amount needs to be released in two instalments.
- 1st - After 1 week of batch starts i.e before 9th January, 2021

- 2nd - After 10 days of batch completion i.e before 15th February, 2021

- MSC needs to share the complete information of students with GS and based on that, GS will share the amount 100rs/participant for above 30+ students.

2. PROPOSED MODES OF COLLABORATION

MSC and GS propose to collaborate through each of the above modes of interaction will be initiated by entering into a separate agreement between the two parties.

3. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire after 3 MONTHS of signing. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Research Agreement, Confidentiality clause as referenced in clause 6 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such terminate.

4. RELATIONSHIP

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.

5. SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.
