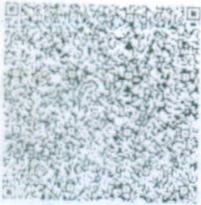

Memorandum of Understanding

By and
Between

*Al Zahra College for Women
Muscat, Sultanate of Oman*

And

*Mata Sundri College for Women
Delhi, India*

This is a Memorandum of Understanding (herein referred to as MoU) between Al Zahra College for Women (herein referred to as ZCW) located in Muscat whose address is as P. O. Box: 3365 P.C.: 111 Airport Heights- Sultanate of Oman and Mata Sundri College for Women (herein referred to as MSCW) located in Delhi, India whose address is as Mata Sundri Lane, New Delhi -110002 Delhi, India (herein after individually referred to as "party" and collectively as "parties" and shall include its lawful representatives and permitted assigns; (hereinafter referred to singularly as "the party" and collectively as "the parties" for mutual benefit of the students, faculty and staff of both the parties.

The First Party:

Al Zahra College for Women (ZCW) was established in 1999 based on the Ministry of Higher Education's Decree No. 99/388. The college officially opened in February 1999 offering classes under the supervision and administration of Oman's Ministry of Higher Education. The College is distinguished from its counterparts in that it is the exclusive female college for Omanis and non-Omanis living in the Sultanate of Oman. English is the primary medium of instruction except in the academic program areas of graphic design and law in which Arabic and English are used, With approval from the ministry of higher education, the college has added a Master's degree in Business Administration (MBA), a bachelor's degree in Law, a bachelor's degree in English Language and Translation and a bachelor's degree in Software Engineering Science. college also awards bachelor degrees and diplomas with specializations in English Language and Literature, Computer Science, Graphic Design, Financial and Banking Sciences, Accounting and Business Administration.

The Second Party:

Mata Sundri College for Women (MSCW) is an institution where we strive to achieve excellence in higher education and women's empowerment. A constituent college of the University of Delhi, the college was founded on 17th July 1967. MSCW has student strength of 4128 vibrant young women in the college. There are 188 distinguished faculty members and 75 members of the non-teaching staff. The college offers 11 Major Disciplines, which includes Commerce, Economics, English, Hindi, History, Mathematics, Philosophy, Political Science, Punjabi, Psychological Science and Sanskrit. With its extremely well-qualified teaching faculty backed by an efficient support staff, the college provides an ideal learning environment for young women, as they embark their journey of life, to give shape to their cherished dreams and wings to their creative pursuits.

Both the parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of co-operation and collaboration to assist each other in building capacity for students exchange and other research activities as mentioned in details in this MoU. Through this MoU, both the parties agree to explore and exploit opportunities of cooperation from each other and have reached an understanding as follows:

Article-1

Student Exchange Program: Where a number of students of both institutions mutually undertake a visit for a certain period for academic purposes and exposure programmes resulting in self- development and awareness among students.

Article-2

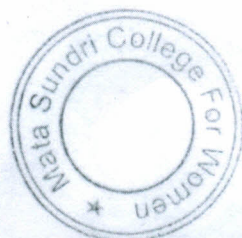
Faculty Exchange Program: Where faculty of both the parties mutually visit for a certain period for various academic/collaborative purposes and projects.

Article-3

Joint Seminar/ Symposium /Workshop: Both parties can arrange collaborative ventures to organize international seminars/ symposiums/ workshops with participants from both universities and other universities in India or abroad.

Joint Faculty Development Program (FDPs): Both parties can conduct joint FDPs to facilitate up gradation of knowledge and skill training to teachers employed in various disciplines.

Article-5

Joint Publications: Faculty and researchers of both parties can arrange publication of books, book chapters, journals and other academic and general publication media.

Article-6

Sharing of Library Resources: Both parties will facilitate in sharing their library resources (which includes books, journals, e-resources and databases).

Article-7

Both Parties shall enhance and encourage, subject to mutual agreement, exchange of select information for the purpose of external Benchmarking to further improve the quality of education, at both institutions.

Article-8

Both parties shall share select relevant information (as deemed appropriate by each Party) in the domains (including sub-domains, activities and/ or processes) of Academic Departments (including Programs, Curriculum, Assessment, Faculty Qualification, Infrastructural facilities, Software, Teaching Load, Faculty-Student Ratio, Academic Advising and any other areas as deemed appropriate by each Party).

Article-9

Both parties shall share select relevant information (as deemed appropriate by each Party) in the domains of Student Registration, Student Affairs, Examination, Library, Human Resource, IT Support, and General Support Services.

Article-10

Both parties, with mutual agreement, shall decide upon the modalities and modus operandi for execution of these modes of cooperation as mentioned under Article-1 to Article-10 above.

Article-12

Each Party shall not use any means forbidden according to laws in Oman and India to access, retrieve, store, print, copy, upload, and/ or reproduce data provided by the other Party.

Article-13

Both the parties shall maintain the complete confidentiality of data shared and shall not use data obtained from the other Party for any commercial purpose, without obtaining prior written consent from the Party providing data.

Article-14

- a. This Memorandum of Understanding shall come into effect on the date of signing by parties and shall remain in effect for a period of 3 years.
- b. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the parties unless terminated in accordance with the terms of this MOU.
- c. Each Party may terminate this Memorandum of Understanding by giving the other Party 60-days written notice expressing the intention to terminate the agreement, without assigning any reason(s) for communication concerning such an intention.
