

# MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding has been made and executed at Delhi on the 23<sup>rd</sup> January, 2021;

## BETWEEN

**Inner Happiness Index** is a sole proprietorship *firm*, registered in Gurgaon (GSTIN 06ABVPV6359H1ZR), owned by Ms. Shalini Vikrant (hereinafter called the party of the first part or the First Party);

## AND

**Mata Sundri College For Women**, incorporated under University of Delhi, 1967 having its campus at Mata Sundri Lane, New Delhi - 110 002, through the principal of the college Dr. Harpreet Kaur (hereinafter called the Party of the Second Part or the Second Party).

**WHEREAS**, the first part is Sole proprietorship firm since 2021 having a Registered office in Gurgaon. The first party provides professional consultancy services on inner well being, personal growth, stress management to name a few.


**AND WHEREAS**, the second party is a college under the University of Delhi, since 1967 to provide education in various branches of Science, Arts and Commerce and to disseminate knowledge in these branches.

**NOW THEREFORE**, the aforementioned parties have agreed to the terms and conditions as mentioned hereinafter in order to conduct an online thirty hours course including practical and assessment on Building a positive self image for success;

1. First party will design thirty hours online course on 'Building a positive self image for success' (hereinafter referred to as course) with concurrence of second party.
2. Course will begin in January 2021 and it will be open for students of all semesters from all disciplines including students from other colleges.
3. Course details/content/structure will be circulated through web portal and social media platforms of both parties to secure students participation in this course.
4. This course will be a skill enhancement course which will aim to improve life skills of students.
5. First party will appoint Ms. Shalini Vikrant instructor for this course.
6. Course instructor will **NOT** be an employ of second party. **NEITHER** he will get any appointment letter from second party **NOR** will be entitled to any salary, allowances or perquisites from second party.
7. First party in collaboration with second party will issue certificates to the students after successful completion of course.
8. First party reserves right to appoint teaching assistants for instructor.
9. Second party will charge and collect a fee of Rs. 300.00 (three hundred rupees) per student for this course and 70% (seventy percent) of total collection, will be reimbursed to First party.

- ◆ To issue certificates


**Second party**
